

ANNIE P. ROGERS STATE GRAND ASSEMBLY ORDER OF THE GOLDEN CIRCLE

GUIDELINES FOR NOMINATING COMMITTEE

The Constitution and By-Laws for the Order of the Golden Circle as created and approved by the United Supreme Council of Sovereign Grand Inspector General's provide for the election of officers of a duly constituted State Grand Assembly at its annual State Grand Assembly. All documents and information must be on Assembly letterhead with the Assembly seal affixed.

All officers of the Annie P. Rogers State Grand Assembly shall be elected. They are State Grand Loyal Lady Ruler; State Grand Loyal Lady Associate Ruler; State Grand Loyal Lady Priestess; State Grand Loyal Lady Guide; State Grand Loyal Lady Treasurer; State Grand Loyal Lady Secretary; State Grand Loyal Lady Herald, State Grand Loyal Lady Standard Bearer; State Grand Loyal Lady Inner Guard; State grand Loyal Lady Outer Guard; State Grand Financial Secretary.

Marshalls and assistant secretary shall be appointed.

The stated rules for nominations are prescribed below and shall be adhered to by each Assembly and member desirous of being nominated in the Orient of North Carolina.

- Each person seeking nomination for an office in the Annie P. Rogers State Grand
 Assembly must have served one full year as a Loyal Lady Ruler in a North Carolina
 subordinate Assembly.
- Each nominee must submit a letter of recommendation from her Assembly. The letter of recommendation must be signed by the Loyal Lady Ruler and Loyal Lady Secretary. The Assembly seal must be affixed to the same.
- The position to be considered for nomination should be clearly stated.

The nominee must submit a written resume with the following:

- Date of initiation into a North Carolina Golden Circle Assembly.
- Name and number of Assembly where membership is held.
- Activities in Assembly, church community and other organizations.
- Skills relative to the position to which she aspires.
- Applicants must be financial.
- Applicants must have attended two (2) area meetings during the calendar year. Must have a letter from the Area secretary verifying attendance. (dates)

- Applicants must have attended eight (8) subordinate Assembly meetings during the calendar year.
- Applicants must have attended the last three(3) consecutive Annie P. Rogers State Grand Assembly sessions. Must have a letter from Annie P. Rogers State Grand Secretary verifying attendance. (dates)
- Assemblies who have current State Grand Officers must follow the same guidelines.
- The same applies for nominations from the floor.
- All resumes except those from the floor must be turned in to the committee by the deadline to be determined by the nominating committee.
- All nominations are to be mailed/emailed to the chairman of the nominating committee.

REMEMBER ALL NOMINATIONS ARE TO BE SENT TO THE CHAIRMAN OF THE NOMINATING COMMITTEE.
