Purpose:

The following is provided to ensure the candidate has all the necessary information and instructions to properly complete the **Recommendation for Thirty-Third Degree, Honorary Membership** application for elevation and become a student of the 2026 Dr. G. Wesley Allen Council of Deliberation 33rd Degree Class.

Primary Contact:

The administrative contact for the application process is Grand Inspector General (GIG) Morris Harris. GIG Harris' email address is **morris.m.harris@gmail.com**. The candidate can send their **signed** application (that is fillable) along with their Biographical Sketch via email to GIG Harris. The application package may also be mailed to the address listed at the bottom. For questions pertaining to the application and/or process, please use the email address above.

Fees:

Once GIG Harris receives the candidate's application, he will reach out to the candidate with instructions regarding the required fees. GIG Harris is the only person who should be providing this information to the candidate.

Key factors to an application being completed successfully:

1. Pay attention to detail. Read every part of the application before entering the requested information.
2. As part of the application package, the candidate is required to submit a Biographical Sketch (no more than one page) about themselves and family, their Masonic resume, and their current career, and community service.
3. BE SURE to provide the CORRECT crown size, ring size, suit size, and height. DO NOT GUESS.
4. Double-check the application package for accuracy before sending it to GIG Harris.
5. **THE APPLICATION PACKAGE AND FEES MUST BE RECEIVED, NO LATER THAN FEBRUARY 28, 2026.**
6. Once the application package has been submitted, be patient while awaiting next steps.
